### Rules and Regulations of the Milford Community Cemetery, Inc.

The cemetery reserves the right to repurchase this lot or any part of it, at original cost, if a transfer is contemplated to anyone other than a member of the immediate family of the owner.

Trees may not be planted in any lot.

All other plantings must be approved by the cemetery board.

During mowing season all flowers, other than funeral flowers, should be placed within six inches of the stone.

Glass containers should not be used in the cemetery.

No railings, curbing or fences will be permitted.

Corners posts will be set at ground level without disturbing original surveyors markers.

Individual and double markers of granite, marble or bronze must be set on concrete foundations with tops level with the ground for ease in mowing.

Monuments must be installed on concrete foundations on the west edge of the lot and at least 12 inches from adjoining plots.

The cemetery is not responsible for damage to monuments or markers or for theft of flowers, flower holders, vases, etc.

All Christmas decorations will be removed after March 1<sup>st</sup>.

## MILFORD COMMUNITY CEMETERY INC. RULES AND REGULATIONS

- We ask for your assistance to help make the Milford Community Cemetery as attractive as possible while being able to maintain the grounds adequately and efficiently.
- <u>Stones and other loose materials</u> present a significant safety issue when maintaining the grass with the risk of the stones getting flung by the mowers or string trimmers, causing damage to the headstones or injury to workers or cemetery visitors. We ask that you please refrain from placing loose materials in front of the headstone unless it is contained by a permanent border. A permanent border must be made of a solid material which can be maintained around (brick, pavers, metal, etc.). Plastic fencing is not permitted.
- <u>Glass items</u> placed at the cemetery have the significant risk of being broken causing a serious safety concern and are not permitted.
- <u>Trees and shrubs plantings</u> must have the approval of the cemetery board and must be maintained by the lot owner or designee. Any planting not maintained will be removed.
- <u>Flowers, statues, vases, flags, solar lights,</u> or any other items are permitted if they are properly maintained. Please be mindful that many of these items will deteriorate in the elements. If any of these item's fade, break or otherwise, please remove them or the Cemetery Board will have them removed.
- The Cemetery Board is not responsible for damage to monuments, markers, flower holders, saddles, etc. The cemetery is subject to foot traffic and strong winds/weather may cause damage or carry items from the grave sites.
- Within 30 days of a burial, the Cemetery board will plan to have funeral flowers removed from the grave site and grass to be planted.
- We appreciate your assistance and cooperation in these matters which will keep the cemetery a respectful place which honors all our loved ones.

- 2. Fine grade aggregate as needed for pavement.
- 3. Apply tack coat as needed.
- Patch with Type "C" surface course hot mix and compact to a thickness of 2" on approx. 452 SY. 4.
- Clean up and haul away any debris generated by our construction activities. 5.
